Spotlight: With migration and job loss and loss of subsistence income for families back home, what should be medium and long-term interventions to support. How can companies engage through CSR; need for rebuilding the livelihoods of vulnerable populations in the post COVID-19 world? how can industry support urban poor?

Collaborate: Technology Revisited

Spotlight: Given the backdrop of ongoing uncertainty, most of the workforce has moved to remote working environment, creating significant challenges for organizations to ensure continuity of operations in the new way of working. The importance of technology in our lives has never been more apparent. Covid -19 has reshaped the tech priorities for companies, including greater investments in telehealth,

cloud infrastructure and contactless digital alternatives to touch interfaces. This session will focus on how technology played an enabling role in development programs; how companies are delivering CSR programs innovatively; how companies have integrated technology to support our communities; especially on how tech is transforming health and education in India; successful examples; also in the current crisis how can technology retrofit existing structures to meet the needs of new reality; scope of partnership for collective action;
